Use measuring stick No. 10 Green.

Mix the components in a plastic can, mix thoroughly after adding each of the components. The amount of Activator WB depends on climate condition and personal viscosity preference.

Application process & blending



Apply a medium closed coat, allow for 3-10 minutes flash-off and apply a full coat. Flash off 3-10 minutes before baking.

Recoatable with itself within 24 hours
For blending, see TDS S8.01.01.

Pot-life

Autoclear WB 2.0 1 hour at 20°C

Film thickness

By using the recommended application: 50-60 µm.

Dry to handle*

Drying times

Allow for a minimum of 5 minutes flash-off time at 20°C before moving the car into a pre-heated drying oven (booth) at 60°C. All drying times relate to standard application and object temperature. Consider the time required for the spraybooth to reach an acceptable air temperature to enable the heat transfer of 60°C to the object.

*Do not use any type of air acceleration or drying equipment during the drying cycle of the Autoclear WB 2.0

Following the drying cycle at 60°C object temperature, allow the Autoclear WB 2.0 to cool down fully to ambient temperature 20°C <u>inside</u> the spraybooth before placing the object in an area with a minimum temperature of 15°C for optimum the through hardening. In case of lower area temperatures, i.e. winter times, extend the drying time by 15-20 minutes at 60°C.
